We realize that we are now reaching a crossroads in education once again with all the challenges ahead. Very often, we hear people in various corners talk about the disruptive power of information technology, artificial intelligence (AI) and how students of the new gens learn. These are what we, educators will have to seriously think about.

Thus, we hope that you will enjoy, as usual, this volume of RJES. The authors have tried their best to identify the areas that need our closest attention. The first paper starts with a case study by Alan Robert White entitled "A Case Study: Exploring the Use of the Line Application for learning English at a Thai University" to give an example of how our teaching and learning of English will be greatly influenced by information technology. The fifth paper "The Use of Grammatical Collocations with Prepositions and Attitudes towards Collocations Learning of Thai EFL Undergraduate Students" by Suthipong Pisitsenakul is a study on the English Language system, an attempt to find ways to help our English students to learn English better. Lastly, Thanyapatra Soisuwan and Anchalee Chayanuvat's paper "Roles, and Professional Needs od Instructional Assistants in an International Characteristics School" reminds us that another group of people in their supportive roles in an International school need to be professionally developed as they are very close to our students.

Food for thought in this volume is a Professional Reflections article by Jamie Wallin and Boonsri Cheevakumjorn, who kindly discuss "Bilingual Education: Some History and Some Clarifications" to show how we can successfully adopt it.
