ABSTRACT

1. Introduction

Throughout our lives we have many memories, both good and bad, with each memory arising from various situations and feelings. Sometimes as time passes, those memories would begin to fade. As a consequence, people began to collect the memories they needed by bringing things to help remind them what happened that day and how did they feel during that time. Additionally, people can always rebuild memories until being breathless. When people die, no new memories arise. Their bodies are gone, but the memories remain in people's hearts. Therefore, there should be an urn to store all the memories of their loved ones.

An urn is the last thing left by the departed, and has been used by many civilizations. After death, the corpse is cremated, and the ashes are collected and put in an urn. Pottery urns, dating from about 7000 BC, have been found in an early Jiahu site in China (Hu, 2005), where a total of 32 burial urns were found, and another early find was in Laoguantai, Shaanxi province (Luan, 2006). There were also about 700 burial urns unearthed over the Yangshao (5000–3000 BC.) area consisting of more than 50 varieties of form and shape. The burial urns were used mainly for children, but also sporadically for adults (Wang, 1997).

About 2500 years ago, the Thai urn was large because cremations were not yet conducted, so the whole body was placed into a monument call a stupa. This was for only the royal family or nobles who made a stupa to show their honor and greatness. As Indian culture was introduced, cremation took place, and the urn was made smaller and many people could use it. As can be seen, an urn has been used to collect ashes from the past to present, and not only the Thai urn, but the urn of each country. Overall, they may have a slight difference in shape and size, but there is not much variety and it is very difficult to distinguish the country of origin. In Thailand, people do not have much choice as the urn is only made from brass and only has a stupa shape. Therefore, this makes the Thai urn not have a unique identity but looks old and scary. As such, they all look the same that can make people confused and difficult to find their family urn

Cremation has increased dramatically worldwide in recent years because the major problem is burial on land. The population is increasing, so there is a need for more ground, but the world has limited ground. Consequently, the ground has been gradually depleted and land prices are rising. Hence, people have realized and turned to cremation instead. Nonetheless, there is also the problem of transportation that the incineration can be moved more easily than a burial.

In only nine years, the cremation rate has increased noticeably. In Canada, for example, it increased from 58% in 2010 to 73% in 2019 (The Cremation Society of Great Britain,2020), thus, the increase in cremation has equaled more demand for urns. In fact, most Western countries are Christian, where people are not allowed to be cremated and only buried, but the era of religion has changed, so people are allowed to be cremated.

2. Objectives of the Study


- 1. To increase the choice for Thai people to use urns that have a variety of styles.
- 2. To reduce the use of space for the stupa that must be built to keep the urn in the temple.
- 3. To add uniqueness to each urn to be outstanding and reflect the identity of the departed.

3. Materials and Methods

3.1 Cremation

According to statistics from the National Funeral Directors Association (NFDA) (2017), more than half of all Americans who die in 2017 will be cremated.





In 20 years, the NFDA predicts, nearly 80% of people would opt to have their bodies turned into ash.

Factors contributing to the increase in cremation are the prices, transportation, and cremation site that is considered less costly since it lowers costs by saving on terrestrial space. Additionally, a cremation is a simpler process that also helps save ground space unlike in the case of a burial. Cremations are also more cost-effective than burials, as they do not require embalming. In addition, people have the option of storing the body in an alternative container instead of a coffin. Furthermore, global cremations have seen a marked increase; for example, Canada went from 58% to 73% within 10 years (The Cremation Society of Great Britain,2020). As a consequence, when there are more cremations, the demand for urns also increases. Most funeral industry metrics use cubic inches as the standard of measurement. A cubic inch refers to an area measuring 1" wide by 1" deep by 1" high.

For every kilogram that the person weighed prior to cremation, there would be one cubic inch of cremated remains (i.e., ashes) after cremation. For example, the remains of a man weighing 80 kilograms would generally equal about 175 cubic inches. The standard urn is 200 cubic inches (Urns Northwest, 2019).



3.2 Migration

International migration would probably increase during the next decades because migration drivers, including economic pressure, changing age structures, population growth, rapid urbanization, and environmental stress, are likely to persist and intensify. Destination countries that can manage the social and political tension caused by immigration would probably reap the economic benefits that could outweigh the fiscal costs of new migrants. Countries of origin are also likely to experience mixed results from more emigration, including critical skills gaps, decreases in unemployment, and improving education levels (European Union, 2020).




Figure 3. Migration information. Source: World Migration Report, 2020 p. 40




Figure 4. Generation overview.




Figure 5. Interview findings.



4. Results




Figure 6. Framework




Figure 8. Urn flash drive.




Figure 9. Urn doll.




Figure 11. Urn lantern.
